Website Terms of Use

Eligibility

In order to access the Website Services, a Patient must access a link provided by her Psychiatrist for each session and enter information on an interstitial page.

If you are accessing or using our Website Services on behalf of another person or entity, you represent that you are authorized to accept these Terms on that person or entity's behalf and that the person or entity agrees to be responsible to us if you or the other person or entity violates these Terms.

Electronic Communications

Visiting www.psychiatricvirtualclinic.com or sending emails to the Psychiatric Virtual Clinic constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

Using Website Services

Each registered Psychiatrist is authorized to invite and use the Website Services for videoconferences with his or her Patients registered with the Psychiatric Virtual Clinic, and other persons, if any, authorized from time to time by Psychiatric Virtual Clinic and the patient. Use of the videoconference services by any other person or for any other purpose is prohibited.

You agree to be responsible for any telephone charges and/or Internet service fees you incur in accessing the Website Services.

Privacy; Security

The Psychiatric Virtual Clinic represents and warrants to Patient that Psychiatric Virtual Clinic possesses the capacity to comply, and that Psychiatric Virtual Clinic will continuously comply, where relevant, with the provisions of the "Health Insurance Portability and Accountability Act of 1996" ("HIPAA") and the "Health Information Technology and Clinical Health Act" ("HITECH") and all of the standards which are promulgated pursuant to such federal statutes, including the Electronic Transactions Standards, the Privacy Standards, the Security Standards, the Breach Notification Rule and all other standards or rules which may be prescribed by the Department of Health and Human Services subsequent to the effective date of this Agreement as being applicable to the relationship between the Parties created by this Agreement (collectively, "HIPAA").
